 - (iii)** **LIBRARY:-** Year-wise development of College Library and provision of funds for journals and magazines be made.
 - (iv)** **ENDOWMENT FUND:-** sufficient endowment fund as prescribed in rules be created.

(v) **FACULTY MEMBERS:-** At least two faculty members in each subject be appointed as per the decision of the Academic council and Board of Management already circulated to Principals of all the affiliated colleges of University.
